

## PUBLIC NOTICE MACON TOWNSHIP

Pursuant to Public Act 110 of 2006, as amended, the Macon Township Planning Commission will hold a Public Hearing on **December 9, 2020 at 6:00 P.M.**, at the Macon Township Hall, 8320 Clinton-Macon Road, Clinton, Michigan 49236.

The purpose of the Public Hearing will be to consider an application filed by Mustang Mile Solar Energy LLC, a Delaware limited liability company, for a special land use permit for a Large Solar Energy Facility (Solar Farm) consisting of solar photovoltaic panel arrays, electrical collection system, substation, access roads, operations and maintenance center, and other ancillary facilities or structures, on approximately 2,500 acres located in the Agricultural (AG) zoning district.

The parcels that are included in the application for the special land use permit are located in Sections 7, 8, 16, 17, 18, 19, 20, 21, 30 of Macon Township, and are identified in the map and list below. There is no single address for the parcels, but the parcels include the following addresses in Tecumseh: 8477 Pennington Road, 9000 Block Welch Road, 9264 Welch Road, 8000 Block Welch Road, 9432 Welch Road, 10000 Block Macon Highway, 9687 Welch Road, 9000 Block Ridge Highway, 8867 Pennington Road, 10685 Macon Highway, 10314 Ford Highway, 9275 Mills-Macon Highway, 7882 Smith Road, 9233 Ford Highway, 7887 Smith Road, 9415 Tangent Road, 9000 Block Ford Highway, 9992 Tangent Road, 9620 Smith Road, 7000 Block Pennington Road, 10000 Block Ford Highway.

The Macon Township Planning Commission shall provide a recommendation on the application to the Macon Township Board.
