Dean Montrief met with a DTE Vice President, Operations Manager and Supervisor regarding the continual power outages affecting Macon Township. They are going to be adding equipment in the 1 circuit breaker to trip it remotely.

Good evening.

Mary Tommelein – resident of Tecumseh I am speaking tonight as a descendant regarding the future of Lake Ridge Cemetery.

Earlier this year, descendants and residents presented a petition requesting that Macon Township take action to address the long-standing ownership and maintenance issues surrounding Lake Ridge Cemetery. In response, the Township's attorney sent a certified letter indicating that a legal process exists to resolve this matter. However, the letter did not identify what that process is, nor did it provide any steps the Township or descendants could follow to move toward a resolution.

Rather than simply accepting that answer, we have spent the last several months researching the issue.

Descendants have once again contacted the Michigan Department of Licensing and Regulatory Affairs, LARA, which advised us that a formal request for investigation may be submitted. This was completed in late May. Several descendants also met with Senator Jeff Irwin's office to better understand the applicable laws and available remedies. Senator Irwin's staff indicated they would be willing to contact the Attorney General's Office if local efforts fail to produce a resolution.

We were also encouraged to contact the Veterans Affairs agency because Lake Ridge Cemetery is the final resting place of nine veterans, including five Civil War veterans and three World War II veterans. This cemetery is not only a burial ground for our families it is an important part of Macon Township's history.

Through our research, we also learned that state law provides a process whereby ten residents may petition for a cemetery to be vacated. If that occurred, the Township could ultimately become responsible for the expense of relocating remains to another cemetery. I do not believe anyone in this room wants to see that happen.

In addition, the Quiet Title process has been discussed and documentation regarding that option has been provided to the Township. Given that the cemetery association has not functioned for generations, no known claimants have come forward, and many historical records may have been lost when township records were damaged during the move from the former township hall on Welch Road, this appears to be a practical avenue worth exploring. I assume similar legal processes were followed when Macon Township assumed responsibility for Osborn and Macon Cemeteries.

Tonight, we are not here simply to identify problems. We are asking once again for dialog and a partnership.

Would the Township Board consider forming a committee consisting of township representatives, descendants, residents, and other interested stakeholders to explore available legal options and develop a path forward? We believe a collaborative effort could identify a

practical solution that honors those buried there, preserves an important piece of township history, and provides clarity for future generations.

We are committed to working with the Township in good faith.

"We are looking for progress, not conflict," can also be very effective if the atmosphere becomes tense during the meeting.
