GIS system at the county was wrong. The owner is now blank. Every member of the association that operated the Cemetery is deceased.

Janelle Wonderly McClure – public comment was heard regarding Lake Ridge Cemetery. The Township has funded the Cemetery for over 100 years, reconsider the decision to stop funding it, York and Raisin take care of their cemeteries, restore in our budget to take care of Lake Ridge Cemetery.

Ed Scheffler Sr. – public comment was heard. No relatives buried in Lake Ridge Cemetery. Feels that if the township can spend money on attorney fees about ordinances that they can take care of the cemetery. Would be happy to have his tax dollars pay for the cemetery. The Township needs to take care of the cemetery.

Matthew Tommelein – 10700 Ridge Hwy. – public comment was heard. What repercussions has the township faced because of paying for Lake Ridge? Dean – it's a legal issue.

Julia Marshall had a correction to the minutes of a misspelled word. Beth DeJonghe moved, seconded by Charley Downing to approve the August 4, 2025 minutes. Motion carried.
